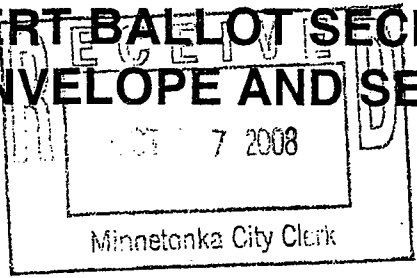

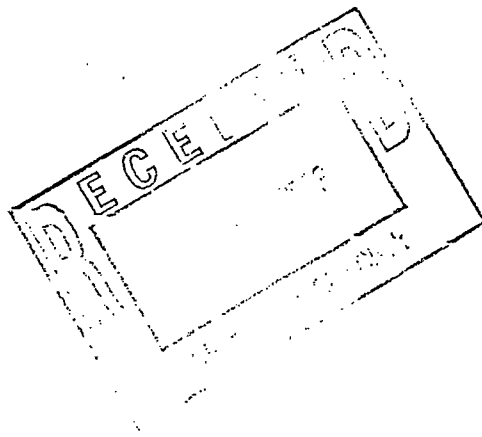



**AFFIDAVIT/DECLARATION OF WILLIAM HOWELL**


1. My name is William Howell. During the first week of December, I spoke with the Minnetonka City Clerk David Maeda about the ballots of Burton and Jane Bolter. Copies of Mr. and Mrs. Bolter's ballot envelopes had been provided by the Minnetonka City Clerk's office in response to a request by the Franken Campaign. The Franken Campaign had requested the names of voters whose ballots had been rejected and the reasons for that rejection. The Bolters' ballots had been marked as accepted on their face but were in the rejected pile provided to the Franken Campaign by the Minnetonka City Clerk's office. Because of this apparent discrepancy, I called Mr. Maeda to get clarification. I learned from Mr. Maeda that the ballots had been rejected at the precinct by precinct election judges likely because of an apparent discrepancy in the apartment unit on the voter registration database and that on the ballot.
