The Complainant, being duly sworn, makes complaint to the above-named Court and states that there is probable cause to believe that the Defendant committed the following offense(s):

That during July 2008, with venue in Dakota County, Minnesota, PETER ROBERT STIBAL, II did engage in sexual contact with another person, and the complainant was at least 13 but less than 16 years of age and the defendant was more than 48 months older than the complainant and in a position of authority over the complainant, to wit: Victim #3.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Your Complainant is a police officer with the Burnsville Police Department. In that capacity I have reviewed the police reports and believe the following to be true.

During October of 2009 a report of criminal sexual conduct was made to the Burnsville Police Department. The investigation into the report led to three separate victims reporting allegations of sexual assault by Peter Robert Stibal, II, DOB: 2/19/65. Stibal was identified by all three victims as the Scout Master of their Boy Scout troop. Boy Scout Troop #650 confirmed that Stibal was an Assistant Scout Master since 2000 and in 2003 he became Scout Master of the post. Stibal remained Scout Master until October of 2009.

Victim #1, born in 1990, stated that he was sexually assaulted by Stibal on at least four occasions. Victim #1 reported that all four incidents took place between 2002 and 2005 when he was between the ages of 12 and 15. Victim #1 reported that the first incident happened sometime in 2002 or 2003 at Stibal's cabin located near Paynesville, Stearns County, Minnesota. Victim #1 reported that he was sleeping near Stibal and woke up to find Stibal with his hand down Victim #1's pants. Stibal's hand was on Victim #1's penis. Victim #1 reported that Stibal eventually performed oral sex on him to the point of ejaculation. Victim #1 reported that the second incident took place at Stibal's home in Burnsville, Dakota County, Minnesota. During this incident Stibal again touched Victim #1's penis with his hand. Stibal then left the residence and Victim #1 looked on Stibal's computer. Victim #1 located a video on the computer that showed children, approximately 8-12 years old engaged in sexual contact and oral sex. Victim #1 also located two written stories on the computer that discussed sexual contact between adult males and children. Victim #1 indicated that the third incident took place at a movie theater in Eagan and the fourth incident took place at a drive-in movie theater in Cottage Grove, Washington County, Minnesota. The third incident involved Stibal touching victim #1's penis. The fourth incident involved Stibal touching victim #1's penis and then performing oral sex on him. Victim #1 stated that sometime around the age of 15 or 16 the abuse stopped when he told Stibal that it made him uncomfortable.

Victim #2, born in 1992, reported that sometime when he was 11 years old, between April of 2003 and April of 2004 he was at a Boy Scout Camp in Stearns County, Minnesota, with Stibal. One night when victim #2 was sleeping he woke up to find his jeans unzipped and Stibal stroking his penis.

Victim #3, born 1994, reported that he was sexually touched by Stibal on three occasions. All three sexual assaults happened when victim #3 was sleeping and woke up to find Stibal

touching his penis. Victim #3 remembered that the last incident happened on July 4, 2008 at Stibal's cabin near Paynesville. Victim #3 reported that he and his family were staying in their motor home at Stibal's cabin. One night Stibal slept in the motor home with them. On the morning of July 4, 2008, everyone left the motor home except victim #3 and Stibal. Victim #3 woke up to Stibal rubbing his penis with his hand. Victim #3 further stated that the other two incidents happened at a Boy Scout Camp in Hubbard County, Minnesota.

All three victims live in Dakota County, Minnesota.

A search warrant was executed at Stibal's residence in Burnsville, Minnesota, on October 15, 2009, and several computers were seized. Stibal was at his residence and provided a statement on the same date. Stibal admitted to being the troop leader of troop #650. Stibal admitted to sometimes being alone with individual boy scouts which he knows is a violation of scout policy. Stibal admitted to giving back rubs to some of the scouts but denies ever sexually assaulting them. When asked about what might be found on his computer Stibal admitted that the video would be on there where there are children performing oral sex on one another. Stibal was arrested in Stearns County on October 19, 2009.

Complainant requests that Defendant, PETER ROBERT STIBAL, III, subject to bail or conditions of release, be:

- (1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court, or
- (2) detained, if already in custody, pending further proceedings, and that said Defendant otherwise be dealt with according to law.
